With reference to the Ministry of Culture's approval letter No.ASI-17/28/2025-ASI/Asiatic(Part-1) dated 19.01.2026, I am directed to convey the approval of the Director, Anthropological Survey of India for award of work to **M/s Axis Communication** for execution of works and services in connection with the celebration of **Parakram Diwas, 2026 at Sri Vijaya Puram**, against the Tender Notice No. 2025_AnSI_891058_1 dated 23.12.2025, on the terms and conditions detailed below:-

1. Scope of Work

The firm shall execute the works/services in a professional and time-bound manner as per approved specifications in the Quotation and directions of the Department excluding the items as enclosed in the **Annexure-I**.

2. Contract Value

The total value of the work shall be **₹.4,39,21,901/- (Rupees Four crore thirty nine lakh twenty one thousand nine hundred and one only)**, inclusive of all taxes, duties, levies, transportation, installation, manpower, tools, equipment and any other incidental charges, as applicable.

3. Period of Contract

The work shall be commenced immediately upon issue of this Work Order and completed as per the RFP, strictly adhering to the timelines prescribed in the RFP.

4. Performance Security

The firm shall furnish a **Performance Security @ 5% of the contract value i.e. Rs.21,96,095/- (Rupees twenty one lakh ninety six thousand ninety five only)** in the form of a Bank Guarantee/Demand Draft in favour of Pay and Accounts Officer, Ministry of Culture, Kolkata as per **Rule 171 of GFR, 2017, on or before 22nd January, 2026**, failing which the Work Order is liable to be cancelled.

5. Payment Terms

- Payment shall be made **after successful completion of the work**, certification by the competent authority, and submission of correct bills in all respects.
- No advance payment shall be made, except as permissible under GFR, 2017.
- Statutory deductions, if any, shall be made as per Government rules.

6. Liquidated Damages

In case of delay in execution within the stipulated time, **necessary action will be initiated as per the rule of GFR, 2017.**

7. Quality and Compliance

The firm shall ensure that:

- All materials and services conform to prescribed quality standards.
- Safety, statutory, and local authority requirements are strictly complied with.
- Any defects noticed during or after execution shall be rectified at no extra cost.

8. Termination of Contract

The competent authority reserves the right to terminate the contract at any stage without assigning any reason, in whole or in part, in public interest, as per **Rule 173 of GFR, 2017.**

9. Force Majeure

Neither party shall be held responsible for delay or failure in performance due to reasons beyond control such as natural calamities, war, riots, or Government restrictions.

10. Arbitration & Jurisdiction


