Principle Objectives

2.0 EOI Processing Fees

A non-refundable processing fee for Rs.500/- (Rupees Five Hundred only) in the form of a Demand Draft or a Pay Order drawn in favour of Pay & Accounts Officer, Ministry of Culture, Govt. of India, Kolkata-1. Payable at Kolkata has to be submitted along with the EOI response. Bids received with or without inadequate EOI processing fees shall be liable to get rejected.
